Thousand Only) in cash for funding the Trust known as C.B. Singh Educational Trust AND WHEREAS it is necessary to declare the objects and terms of Charitable Trust being constituted under these presents.

NOW THIS INSTRUMENT OF PUBLIC CHARITABLE TRUST WITNESSETH AS FOLLOWS:

- a) That the name of the public charitable trust shall be C.B. Singh Educational Trust.
- b) That the aim and object of the trust shall be:
 - i) To open, run and continue an institute for legal education of Boys & Girls & Vocational pursuits and to develop career and character of students and to do all acts and Things necessary for promotion of Legal Education and Other Educational Institution at Akbarpur, Distt.-Ambedkar Nagar and elsewhere and for this purpose to start, establish, construct, conduct, maintain and manage class rooms, libraries, hostels, residential quarters and the like for the purpose of imparting education etc. for the boys and girls of

- ii) To affiliate other educational institutions in the Trust.
- iii) To obtain or accept subscription, donations, grants, gifts and devices from any person, firms, corporation, institutions, Govt. and semi Govt. and other organisations. However acceptance of donation etc. shall be under the discretion of the founder Trustee.
- iv) To acquire by gift, purchase, exchange, lease, hire or otherwise any land or building, easement right of common play grounds, parks or any property movable or immovable and for any estate or interest for the furtherance of all or any of the objectives of the trust.

- v) To print, publish and exhibit any book, pamphlets or posters that may be considered desirable for the promotion of the objectives of the trust.
- e) That the head-office of aforesaid trust shall be at Vill. & Post-Meerpur Sekhpur (Akbarpur), Distt.-Ambedkar Nagar (UP).
- d) That the Founder Trustee namely Sri Shiv Sahai Singh is designated as Chairman of the trust who shall be in-charge of the day to day affair of the Trust.
- e) That the board of trustees shall consists of trustees mentioned from 2 to 5 hereinbefore with its-Chairman Sri Shiv Sahai Singh.
- f) That the Chairman shall have the powers to administer the funds of the trust and any power exercisable by the Board of Trustees.
- g) That the Chairman and all other four trustees mentioned above shall hold office for life or until either resigns therefrom or are remove by the Board of Trustees.

- h) That the Chairman may during his life time name and appoint his successor and such appoint successor shall have the same powers which the chairman possessed.
- i) That the Chairman shall have overall powers of superintendence over the affairs of the trust and shall have in particular the power to open and operate bank accounts, borrow money for the benefit of the trust and carryout the object of the trust.
- j) That the Chairman shall have also the power to entrust or delegate any of his powers to the board of trustees or to any one or more of the trustees for running the affairs of the Trust including power to operate the bank accounts or the trust.
- k) That the proper accounts of the trust shall be maintained and kept at the office of the trust.
- l) Whereas the initial Contribution of Rs. 5000 (Rupees Five Thousand Only) made by the founder trustee namely Sri Shiv Sahai Singh shall hereby vests in the Trustee and shall constitute initial trust fund.

- m) That the funds of the trust shall not be applied for any purpose other than the objects of the trust stated hereinbefore.
- n) That the board of the trustees and/or Chairman shall have the power to acquire movable or immovable properties, lease, mortgage, sell or otherwise deal with such properties for and on behalf of the trust.
- o) That the rules/by-laws may be framed for the administration of the trust which shall not be against the objects of the trust.
- p) That the board of trustees shall meet as and when necessary or convenient to transact business of the trust. The board of trustees may transact business and take decisions also by circulation of papers/minutes/resolutions etc. All the decisions of the board of trustees shall be taken either unanimously or by majority and if the board is equally divided the chairman shall have the casting vote.

- q) That without prejudice to the powers of the board of trustees, the chairman shall manage and administer the affairs of the trust with the help of secretary of the trust, to be appointed by the chairman or board of the trustees, who shall make all correspondence on behalf of the chairman and shall maintain all records of the office/trust.
- r) That the management and administration of trust shall vests in the board of trustees.
- s) That the funds of the trust may be kept in bank deposits, govt. securities or other securities as the chairman or the board of trustees may decide.
- t) That all acts and proceedings of the trust shall be taken and conducted in the name of the trust.

- u) That any vacancy falls in the board of the trustees (which shall never exceed seven unless agreed by the chairman or by the board of trustees in majority) for any reason shall be filled up either by will of trustee relinquishing trust in whose place the vacancy is to be filled up or by the chairman or by the majority of the trustees of board of trust.
- v) That all the five trustees of the trust which includes the chairman as well, shall be ex-officio members of the governing body, management of the institutes, the trust undertake to run and manage.
- w) That any clause(s) of this instrument may be amended, alter or fresh clause(s) may be introduced by a written resolution by the board of trustees to be taken unanimously or by majority.

- x) That the terms which have not been mentioned specifically hereinabove, INDIAN TRUST ACT shall apply.

By first amendment with unanimous resolution, on 5th October 2014, after the sudden death of the founder trustee/chairman/settlor Shiv Sahai Singh & on 20-07-2014, the founder secretary of the trust has been expired. The two executor, administrator post were lying vacant. In order to fill up the total two vacant representatives. By (Trust resolution no. 14 dated 07-10-2014) Mr. Dheerendra Pratap Singh has been honouring the post of chairman of C.B. Singh Educational Trust at the place of Shiv Sahai Singh & Mrs. Prema Singh has been represented as the new Secretary of the Trust (By Trust Resolution No. 15, dated 25-11-2014). One more trustee has been also inducted by trust meeting (Resolution No. 15 dated 25-11-2014) Mrs. Chandrawati Singh. Now, the trust members are:

And if the school is recognised by "Madhyamic Siksha Parishad", then after that school has been affiliated by C.B.S.E. New Delhi or council for the Indian School, Certificate Examination, New Delhi, then automatically the Madhyamic Siksha Parishad recognised & aid of the government shall be ceased.
